**RESOLVED** by the City Council of the City of Danbury:

Special Meetings of the City Council of the City of Danbury:

- 1. **WHEN HELD** Special Meetings of the City Council may be held whenever, in the opinion of the Mayor, or in his absence the Acting Mayor, the interests of the City shall require, or whenever seven (7) members of the City Council shall so require in writing.
- 2. **WARNING** All Special Meetings of the City Council shall be warned by a written or printed Notice signed by the Mayor or the Acting Mayor left with or at the usual place of abode or place of business of each member of the City Council to be convened not less than 24 hours before the hour specified for said meeting.

Said Notice shall specify the time and place the meeting is to be held and shall be directed to any police officer or constable of the City to serve and return.

- 3. **RETURN OF SERVICE OF WARNING** The Return of the Police Officer or Constable serving Warning of any Special Meeting of the City Council shall be evidence that such meeting has been warned as stated in such return.
- 4. **ITEMS TO BE CONSIDERED** Only those items of business listed on said Notice shall be considered, discussed and acted upon.
